**FIRST AMENDMENT TO INDEPENDENT PEX PRODUCTION AND DESIGN SERVICE AGREEMENT  
With C.J. Wilson, LLC/DBA: Lollipop Productions**

NEVADA COMMISSION FOR THE RECONSTRUCTION OF THE V&T RAILWAY (“Commission”) and C.J. WILSON, LLC/DBA: LOLLIPOP PRODUCTIONS (“the Contractor”) hereby consent to amend the Independent PEX Production and Design Service Agreement dated June 24, 2021 (“Agreement”) as follows:

Further, and as an addition to the Agreement, the Commission and the Contractor agree that the Contractor shall provide PEX production and design services for an additional six nights.

Whereas, the Agreement provides that the Total Contract Not to Exceed value under Consideration is \$72,331.

Therefore, the Commission and the Contractor agree that the Total Contract Not to Exceed value shall be increased by \$13,290, with an amended Total Contract Not to Exceed value of \$85,621.

Except as set forth in this Amendment, all the other terms and conditions of the Agreement remain unmodified; and the Agreement shall continue in full force as hereinabove modified.
