AMENDMENT #1 TO AGREEMENT FOR LEGAL SERVICES

The Carson City District Attorney's Office ("CCDA") and the Nevada Commission for the Reconstruction of the V&T Railway (the "Commission") hereby amend the AGREEMENT FOR LEGAL SERVICES dated July 28, 2022 ("Agreement"), as follows:

RECITALS and TERMS:

WHEREAS, the Agreement is in effect until July 27, 2023, and provides that the term of the Agreement may be extended for additional terms of one year upon mutual approval and execution by the CCDA and the Commission; and

WHEREAS, CCDA and the Commission have determined that an extension of one year to the Agreement is mutually desirable;

NOW THEREFORE, in consideration of the aforesaid premises, mutual promises, covenants and undertakings hereinafter set forth, CCDA and the Commission agree to extend the Agreement for a oneyear term, effective on the day the last required signature is affixed hereto.

It is also agreed that all unaffected terms, conditions, requirements and restrictions of the Agreement remain unaffected and continue in full force and effect for the duration of the one-year extension established by this Amendment #1.

This Amendment may be executed in counterparts, each of which shall be deemed to be an original but all of which, taken together, shall constitute one and the same Amendment #1. In witness whereof, CCDA and the Commission have executed this Amendment #1 on the day and year written below.
