- 6. FOR POSSIBLE ACTION: Discussion and possible action regarding the V&T Commission's statement of accounts payable checks paid May 1–31, 2024. Leah Kruse (admin@vtrailway.com) *Staff Summary: The V&T Commission will review the invoice listing for accounts payable checks totaling \$78,050.42 paid May 1–31, 2024.*
- **7. FOR POSSIBLE ACTION:** Discussion and possible action regarding the adjusted V&T Commission's Fiscal Year ("FY") 2023/2024 budget reports, period ended May 1-31 ,2024. **Leah Kruse** (admin@vtrailway.com) *Staff Summary: The V&T Commission will review a comparative statement of adjusted revenue totaling \$1,469,475.57 and expenses totaling \$1,362,614.41 for May and make a determination whether to approve the report.*
- 8. FOR POSSIBLE ACTION: Discussion and possible action regarding website design and maintenance services, effective July 1, 2024, to June 30, 2028, utilizing State of Nevada joinder contract 99SWC-NV23-17886 with KPS3, for a total amount not to exceed \$56,750.00. David Peterson (admin@vtrailway.com) Staff Summary: The total contract amount includes \$41,700 for discovery, strategy, website design and development, quality test and launch, \$18,000 for ongoing post-launch web maintenance for the three years, and a reduction of \$2,950, for the State of Nevada negotiated rate. KPS3 and the V&T Commission will be using the Nevada statewide contract with solicitation number 99SWC-S2340, with an expiration date of June 30, 2027, and an option to renew for two additional years.
- 9. Discussion and possible action regarding a proposed resolution to augment and amend the V&T Commission Fiscal Year ("FY") 2023-2024 budget in the amount of \$81,100, pursuant to NRS 354.598005.- Jennifer McCain (admin@vtrailway.com) Staff Summary: The proposed augmentation and revision is using unanticipated revenues which will increase both revenues and expenses in the amount of \$81,100 without altering the net income. The process gives the V&T Commission the opportunity to adjust the budget utilizing unanticipated revenue. The need for such augmentations usually come about due to unforeseen circumstances which cause overage within an expense function or object of the budget. The augmentations for FY 2024 pertain to two expense accounts: Royalties, which has a deficit of \$7,287 due to higher-than-expected royalty payments resulting from increased ticket sales; and Capital Outlay, which requires an additional \$73,756, due to higher than anticipated costs for the pavement of the Eastgate parking lot. The augmentation must be approved by a majority vote of the V&T Commission.
- **10. FOR POSSIBLE ACTION:** Discussion and possible action regarding a proposed amendment to Contract for Services of Independent Contractor, FY 24-Coo7, with Aumada Marketing, LLC also known

as Lumont Media ("Contract"), extending the Contract for three additional years, effective July 1, 2024 to June 30, 2027, under the same terms and conditions, for an amount not to exceed \$13,500.00 per year or \$54,000.00 for the three-year renewal period, and a total amended amount of the Contract not exceed \$67,500.00. **David Peterson** (admin@vtrailway.com) **Staff Summary:** *Aumada Marketing, LLC informed staff that it will be rebranded as Lumont Media and that an application has been filed with the Secretary of State. The rebranding will not affect the services they provide, and they would like to extend the Contract for additional three years. Staff is recommending that the V&T Commission approve the amendment of the Contract, as proposed.* 

- **11.** FOR POSSIBLE ACTION: Discussion and possible action regarding a proposed amendment to Contract for Services of Independent Contractor, FY 24-Coo2, with Deitz Media & Marketing, LLC ("Contract"), extending the Contract for three additional years, effective July 1, 2024 to June 30, 2027, under the same terms and conditions, for an amount not to exceed \$7,500.00 per year or \$22,500.00 for the three-year renewal period, and a total amended amount of the Contract not exceed \$37,500.00. David Peterson (admin@vtrailway.com) Staff Summary: *Deitz Media & Marketing, LLC would like to extend the Contract for additional three years. The V&T Commission's budget for media buys is \$50,000 for Fiscal Year 2025, with a commission of 15 percent totaling \$7,500.00 per year. Staff is recommending that the V&T Commission approve the amendment of the Contract, as proposed.*
- 12. FOR POSSIBLE ACTION: Discussion and possible action regarding a proposed amendment to Contract for Services of Independent Contractor, FY 24-Coo3, with Cheryl Bailey ("Contract"), extending the Contract for one additional year, effective July 1, 2024 to June 30, 2025, under the same terms and conditions, for an amount not to exceed \$60,000.00 per year, and a total amended amount of the Contract not exceed \$110,000.00. David Peterson (admin@vtrailway.com) Staff Summary: *Staff is recommending that the V&T Commission approve the amendment of the Contract, as proposed.*
- **13.** FOR POSSIBLE ACTION: Discussion and possible action regarding a proposed Contract No. FY25-Coo1, with Virginia and Truckee Railroad ("VTRR") ("Contract"), for operations management at the Carson City Eastgate Depot, for an amount not to exceed \$95,000.00 per Fiscal Year 2025. David Peterson (admin@vtrailway.com) Staff Summary: *The previous contract with VTRR for the same services expires June 30, 2024. Staff solicited two responses from VTRR and another vendor believed to be capable of performing the contract, pursuant to the requirements of NRS chapter 332; however only VTRR expressed the desire to perform the contract. Therefore, Staff recommends the award of the Contract as proposed to VTRR.*
- 14. FOR POSSIBLE ACTION: Discussion and possible action regarding proposed Amendment #2 to Agreement for Legal Services with Carson City District Attorney's Office ("Agreement"), extending the Agreement for an additional one-year term under the same terms and conditions, for an amount not to exceed \$20,000 per year. David Peterson (admin@vtrailway.com) Staff Summary: *The Agreement is in effect until July 27, 2024, and provides that the Agreement may be extended for additional terms of one*

year upon mutual approval and execution by the parties.

**15.** FOR POSSIBLE ACTION: Discussion, presentation and possible action regarding a report and visual inspection of the V&T Railways and V&T Railway Bridge (G-2898) conducted by Wood Rodgers.– David Peterson (admin@vtrailway.com) Staff Summary: A visual inspection of the V&T Railway was conducted by Wood Rodgers from Gold Hill to the East Gate Depot. *Jim Koch of Wood Rodgers will present findings of the visual inspection performed between January 31, 2024, and May 10, 2024. The V&T Commission is asked to comment on the report and direct staff to address the proposed corrective actions.*
