6. **FOR POSSIBLE ACTION:** Discussion and possible action regarding the V&T Commission’s statement of accounts payable checks paid July 1-31, 2024. – **Leah Kruse** (admin@vtrailway.com) **Staff Summary:** *The V&T Commission will review the invoice listing for accounts payable checks totaling \$81,663.15 paid July 1-31, 2024. Of this amount \$50,346.20 is allocated for FY24.*
7. **FOR POSSIBLE ACTION:** Discussion and possible action regarding the adjusted V&T Commission’s Fiscal Year (“FY”) 2023/2024 budget reports, period ended July 1-31,2024. – **Leah Kruse** (admin@vtrailway.com) **Staff Summary:** *The V&T Commission will review a comparative statement of adjusted revenue totaling \$59,011.79 and expenses totaling \$33,637.26 for July and make a determination whether to approve the report.*
8. **FOR POSSIBLE ACTION:** Discussion and possible action regarding (1) a proposed installation of two FLOCK License Plate Reader devices (“LPRs”) by the Carson City Sheriff’s Office (“CCSO”) on property/infrastructure on Highway 50 East owned by the V&T Commission and (2) authorization for the V&T Secretary to prepare and enter into an agreement with Carson City for the installation of the LPRs. **Staff Summary:** *CCSO is requesting permission to install two LPRs, consisting of a small solar array, battery and camera, on V&T infrastructure, located on Highway 50 East at the Lyon County Line. One camera would monitor westbound traffic and the other eastbound traffic on Highway 50 East. The cost for the LPRs and their installation has already been paid for by the City under a Capital Improvements Project from Fiscal Year 2024. No permanent modifications to the existing infrastructure would be required for installation. Carson City has approved and installed 28 LPRs on existing infrastructure around Carson City. CCSO is proposing one of two possible locations for the installation of the LPRs: the V&T-owned streetlights immediately east and west of the V&T Railway Bridge (G-2898); or the bridge overpass itself.*

****PUBLIC COMMENT LIMITATIONS** – The V&T Railway Commission will provide at least two public comment periods in compliance with the minimum requirements of the Open Meeting Law prior to adjournment. **Public comment will be taken at the beginning of the agenda before any action is taken and again at the end before adjournment.** No action may be taken on a matter raised under public comment unless the item has been specifically included on the agenda as an item upon which action may be taken. The Chair may call for or allow additional individual-item public comment at the time of the body's consideration of the item when: (1) the comment will be provided from a person who is directly involved with the item, such as V&T staff or an applicant; or (2) it involves any person's or entity's due process appeal or hearing rights provided by statute or the Carson City Municipal Code. Comments may be limited to three minutes per person or topic at the discretion of the Chair in order to facilitate the meeting.

Agenda Management Notice - Items on the agenda may be taken out of order; the public body may combine two or more agenda items for consideration; and the public body may remove an item from the agenda or delay discussion relating to an item on the agenda at any time.
